Official Contest Rules, Waiver & Release of Liability

Hosted by Atlético Dallas

Event Overview

- Event Name: Atlético Dallas 1v1 Panna Tournament
- **Date:** August 9, 2025
- Location: Josey Records 2821 Lyndon B Johnson Fwy #100, Farmers Branch, TX 75234
- **Prize:** \$1,000 prize (non-cash equivalent). Winner must complete a W-9, 1099 or any other relevant tax form prior to receiving the prize.
- Registration: Players must arrive at least 30 minutes before their first scheduled match to check-in and sign participation waiver. (ID is required)

Tournament Format

Atlético Dallas will provide game ball and referee.

- Players: 16 total competitors
 - 4 slots reserved for invited pros
 - 12 slots drawn from public entries

Objective

 There are two ways to winning a panna match: By being the first player to score 3 goals or by giving a panna (nutmeg). If you give a panna, the game is immediately over regardless of the score.

What is a Panna?

A Panna is the art of playing the ball intentionally between your opponent's legs.

To do a successful panna:

- You must have possession of the ball.
- A panna only counts if it is on purpose. The attacker deliberately needs to have tried to give the panna.
- The panna needs to happen directly from the attacker's feet.
- The side wall cannot be used to give a panna.

• It's not a panna if the ball is poked through after being caught and locked between the opponent's legs.

Duration:

Matches are 5 minutes long.

- If no one scores 3 goals or gives a panna at end of the 5 minutes, the highest score wins. Each goal is one point.
- If the score is tied, there will be two minutes of sudden death overtime. First player to score or give a panna wins.
- If neither opponent score, the game will be decided with a coin toss

Game Start:

- Late arriving players will risk forfeiting their match. A 2 minute grace period will be given.
- The match starts with the ball between both players backs. When the ref blows the whistle both players may turn around to go for the first ball possession.

Scoring:

- Goals can be scored from everywhere within the panna cage. (get confirmation)
- You cannot use the side wall to score.
- After a goal is scored the opponent immediately gets ball possession at his own goal.

Fair Play Rules:

The following is not permitted:

- Dangerous play
- Physical contact such as holding onto your opponent, or clothing.
- Obstruction (use of body or arms to stop your opponent).
- Holding onto any portion of the side walls.

If a foul is made, the player fouled will get the ball and reset at his own goal. The ref will enforce fairness and can disqualify a player for extreme cases such as violence, verbal abuse, or continuous disrespect of officials.

The ref has final say on all calls.

Entry & Timeline

• Entry Opens: July 25

• Entry Closes: July 27 at 11:59 PM CST

• Live Instagram Drawing: July 28 (12 public players + 4 alternates)

Confirmation Deadline: July 29 at 11:59 PM CST

Alternates Contacted: July 30 if needed

• Live Instagram Draw to determine bracket: July 31
Four pros will be drawn first to fill up first four seeds (1-4), remaining participants will then be drawn to fill up remaining seeds (5-16)

Eligibility & Participation

- Must be 18 years or older
- Must sign combined waiver & contest agreement prior to playing
- Must present valid photo ID at check-in
- Winner is required to complete a W-9 tax, 1099 or any other relevant tax form prior to receiving the prize
- By entering, participants consent to being filmed and photographed during the event

Release, Waiver of Liability & Publicity Consent

1. Assumption of Risk
